The member of public advised that there were issues with the LFS documents being
available to scrutinise. There have been issues raised with Uranium being dumped in
the quarry in 2020. He has worked together with other Councillors and now has a full
document going back to 1959.

The member of public asked if the Parish Councillors are aware of the LFS documents. On the 23/06/2023 a meeting was held with Sir Lindsay Hoyle.

The original application for the new development was refused but now, although there have been no changes the recent application has been approved.

There is asbestos in the tip which is south of Town Lane.

The member of public suggested that the minutes of the meeting and reviewed and appraised from the 1959 documents.

Councillor B Higham asked if there is any reference to the tips in these documents. The member of the public advised that there are references to Industrial Waste. He advised that the Parish Council must take responsibility.

Councillor Yates suggested that there are experts within CBC that should be following up on these issues.

The member of public suggested that he could not keep passing it onto Cllr Mark Clifford.

Cllr Yates advised that the Parish Council had gone far enough, within its remit. Cllr Wood advised that full objections had been made at the time.

The member of public advised that the difference in the applications are required by Sir Lindsay Hoyle. The test carried out in 1959 showed that all was ok with the River Lostock. Mike Halsall from CBC has produced a document for the outline of the River Lostock. The member of public then read from the transcript. He stated that the contamination needs to be reviewed.
